iProbono India works on cases involving child abuse, trafficking, juvenile justice and housing rights, among others, and advocates for these issues. We also provide legal assistance to civil society organisations across the country working on a range of issues as well as engage in advocacy efforts for policy change. Role

We are looking for a Senior Social Worker to lead our Comprehensive Care Team in Delhi - a team member who will provide wraparound support to the individuals and communities we represent, while managing the colleagues who form part of the Comprehensive Care Team. The social worker will provide direct support to survivors of child sexual abuse and their families. They will be responsible for liaising with and reporting to the Child Welfare Committees (CWC), Child Care Institutions and other agencies. The role also entails supporting our other cases, particularly our juvenile justice efforts, by engaging with organisations and child care institutions as required.

Responsibilities

In the capacity of a Support Person assigned to a particular case by the CWC, the Senior Social Worker must:

- Provide direct support to children in need of care and protection and their families.
- Send regular updates to the CWC, as mandated.
- Conduct home visits and identify psychosocial needs requiring immediate attention.
- Work with the concerned stakeholders to help children receive interim and final victim compensation according to the government schemes.



- Proactively liaison with government authorities, especially CWC members, District Child Protection Unit, Delhi State Legal Services Authority, police officials, and counsels.
- Assist children and families for court hearings, attend court hearings and support clients through legal processes wherever required.
- Work closely with panel lawyers on cases where iProbono India is providing legal representation.
- Be the first responder to child sexual abuse victims at the police station and during medical procedures, wherever required.
- Ensure compliance with the provisions of applicable laws and rules applicable to support persons, including provisions of the POCSO Act and Rules, Juvenile Justice (Care and Protection of Children) Act, 2015 etc.

In addition, the Senior Social Worker shall:

- Manage the comprehensive care team, which consists of two social workers and a psychologist.
- Build and maintain relationships with Child Welfare Committees, Child Care Institutions and other agencies.
- Ensure that all information about client cases in the case management system is documented in a consistent, comprehensive and timely manner.
- Identify areas where legal interventions are required and issues which can be addressed through advocacy.
- Participating in training and capacity building sessions for beneficiaries, panel lawyers, partner organisations etc., as required.

Skills and Experience:

- Bachelor's degree in Social Work with 4-6 years of experience OR Master's degree in Social Work with 3-5 years of experience.
- Relevant knowledge of the Child Protection System and the laws like POCSO Act and the Juvenile Justice (Care and Protection Act).
- Managerial experience would be preferred.
- Excellent written and spoken English and Hindi comprehension.
- Strong communication skills and ability to engage with individuals from different backgrounds and communities as well as those dealing with trauma.
- Sound understanding of individual casework and relevant social work methods.
